Participation in and submission of an entry to the Element Electronics 3M Open TV Giveaway (the "Contest") constitutes your agreement to be bound by these Element Electronics 3M Open TV Giveaway Official Award Rules (the "Official Award Rules").

1. **Contest Period**. The Contest shall begin at 8:00:00 AM Central Time ("CT") on Thursday, July 22, 2021 and end no later than 5:00:00 PM CT on Saturday, July 24, 2021 (the "Contest Period"). Entries submitted past the expiration of the Contest Period as set forth above will not be accepted and will be destroyed.

2. **Sponsor and Manager**. The Contest is sponsored by Element TV Company, LP ("Sponsor"), and is managed by 3M Open Fund (the "Manager").

The Entrant must complete all required fields with all required information in the Submission Form for the entry to be eligible (such eligible submission, an "Entry" and collectively, "Entries"). Any Entry that does not contain valid information may be disqualified in Manager's sole discretion. Entries do not carry forward and are not automatically entered in subsequent promotions.

Proof of submission of an Entry shall not be deemed proof of receipt of such Entry by Manager. Manager is the official timekeeper for the Contest. Once submitted, Entries will not be acknowledged or returned. By entering the Contest, each Entrant agrees to be bound by these Official Award Rules and the decisions of Manager in connection with the Contest, whose decisions are final and binding on all matters relating to the Contest. 5. **Submission Requirements**. You must submit your Submission as directed during the Contest entry process. By submitting a Submission, each Entrant represents and warrants that his/her/their Submission is an original work of authorship and that, as of the date of submission, he/she/they owns all right, title, and interest in the Submission or has all necessary rights in the Submission in order to submit it in accordance with these Official Rules. Submissions will only be accepted on the Submission Form.

6. **Contest Winning Criteria**. Entrants will be required to submit their best guess for the final tournament score of the 3M Open in the Submission Form. Manager will select the winning Entrant based on the Entrant's score matching the final tournament score or being the closest possible guess to the final tournament score in the event no Entrant matches the final tournament score exactly (in any case, the "Winning Submission"). If there is only one Winning Submission, the Entrant with the Winning Submission will win the Prize (the "Prize Winner"). If more than one Entrant has submitted a Winning Submission, then the Prize Winner will be selected in a random drawing of all eligible Winning Submissions by Manager.

7. **Odds of Winning**. One (1) Winning Submission will ultimately be selected after the Contest Period to be the Prize Winner. Entries included will be selected from among all eligible entries through the dates of the Contest Period. The odds of winning depends upon the number of entries.

8. **Prizes**. The Winner will receive one (1) Element Electronics 70" Roku TV. Approximate Retail Value ("ARV") of the prize is \$700.00 (the "Prize"). All Entrants will not receive a Prize. The ARV of the Prize, especially retail prices of electronic devices, may fluctuate and change between the date of commencement of the Contest and the date that the Prize is awarded or redeemed. The Prize Winner will not receive the difference between actual and approximate retail values.
